Introduction of AMH SSC

This is to introduce this Sector Skill Council.

The Government of India has constituted Prime Minister's ambitious skill development programme under the leadership of the National Skill Development Corporation. The NSDC mandates skill formation to develop the workforce with enhanced skill through structured programme and assessment.

AMH SSC has been launched jointly by the Ministry of Textiles, National Skill Development Corporation and the Apparel Export Promotion Council with primary mandate of enhancing and to build a capacity in skill development. The assessment is defined as a structured process_ in which evidence of performance is gathered and evaluated against approved QPs/NOSS, as approved by the NSDC.

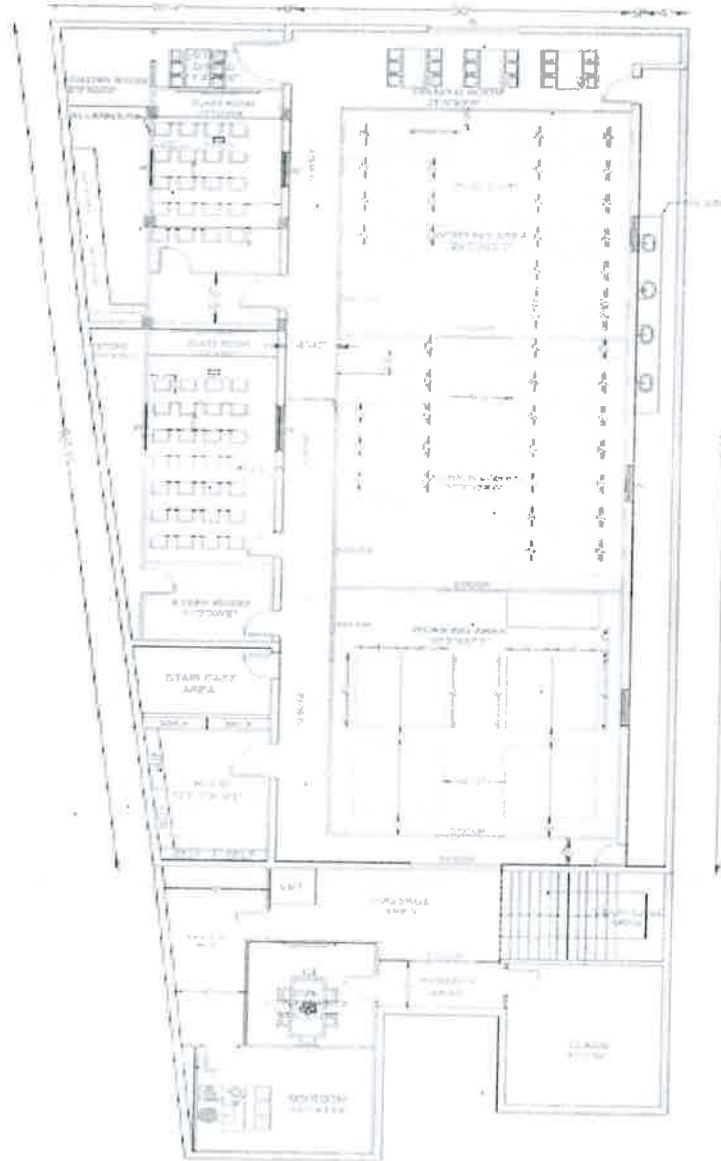

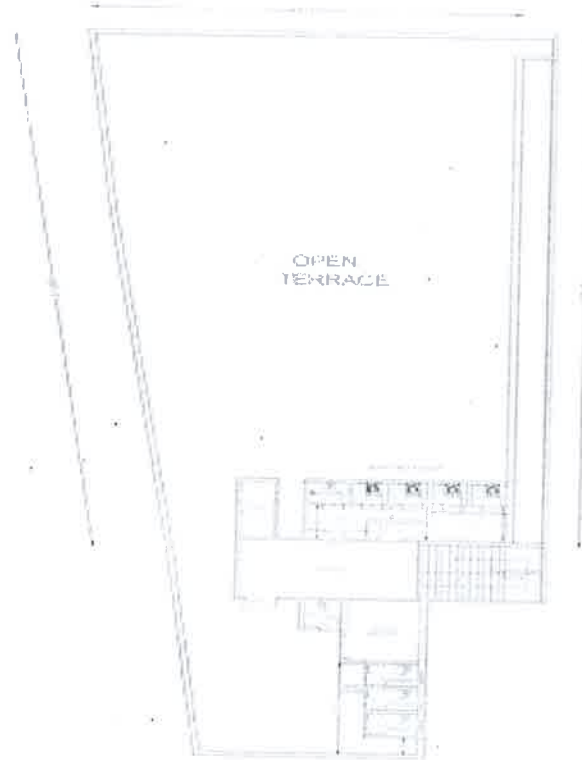

NOTE:

- All materials will be delivered and installed at Tirupur.
- Services are to be provided during office hours (8:30 am – 5:30pm).
- Demolition of interior partitions of an existing false ceiling (ceiling is continuous above the partition). The partitions include light switches and other devices needing relocation.
- Guarantee period should be 48 months from the date of completion of the works against poor workmanship, poor performance, and in case of deficiencies are found during guarantee period, the same shall be rectified free of cost by the Contractors at their own cost and risk.
- Within one month of the completion of the work the contractor shall furnish a certificate for such completion.

- No extension work shall be granted unless for additional work requested by the AMHSSC
- Bidder have to provide interiors of the office space in accordance to the agreed design drawings and specification.
- The construction materials supplied must be in ISI quality.
- First grade of electrical products should be used.
- The vendor needs to provide free service for the period of 48 months.
- Make a separate mention of GST% in the quote.
- The supplier will bear the expense of transportation and installation.
- As this is a Request for Proposal, no information regarding the identity of neither the vendors nor the contents will be released until after the negotiation process.
- Once the RFPs finalized no cost upkeep will be allowed
- The renovation work must be completed within 30 days of the PO's issuance date.
